THE RESIDENCE APPEARED VERY WELL KEPT. THE REFRIGERATOR AND CUPBOARDS WERE WELL STOCKED WITH FOOD AND DRINKS FOR CHILDREN AND ADULTS, HOWEVER, ONLY A SINGLE CAN OF ENFAMIL BABY FORMULA WAS FOUND IN THE RESIDENCE. THERE WAS ONLY A VERY SMALL AMOUNT LEFT IN THE CAN.

LOGAN SAID THE VICTIM WAS BROUGHT HOME WHERE SHE AND GARDNER SHARED THE RESPONSIBILITY OF CARING FOR THE VICTIM. SHE SAID THEY FED HER 2 OZ. OF BABY FORMULA EVERY THREE TO THREE AND A HALF HOURS. SHE MIXED ONE HALF OZ. OF FORMULA WITH ONE AND ONE HALF OZ. OF WATER. LOGAN SAID THE DIRECTIONS ON THE CAN OF ENFAMIL DIRECTED THEM HOW TO PREPARE THE BOTTLE. LOGAN THEN SAID SHE DIDN'T READ THE DIRECTIONS AND THAT GARDNER TOLD HER THAT'S WHAT THE DIRECTIONS READ.

THE DIRECTIONS ON THE ENFAMIL ACTUALLY DIRECT TO MIX EQUAL AMOUNT OF ENFAMIL AND WATER.

LOGAN SAID THE VICTIM HADN'T BEEN SICK OR SUFFERED ANY AILMENTS SINCE BEING RELEASED FROM THE HOSPITAL AND HADN'T SEEN A DOCTOR SINCE HER RELEASE. LOGAN SAID SHE TRIED SEVERAL TIMES TO GET AN APPOINTMENT WITH A DOCTOR BUT WAS UNSUCCESSFUL BECAUSE NO DOCTOR OR DOCTOR'S OFFICE WOULD ACCEPT THE VICTIM'S FORM OF MEDICAID. LOGAN DID SAY SHE RECEIVES SSI BENEFITS FOR HER OLDEST CHILD, SHE ALSO RECEIVES SSI BENEFITS AND SHE IS ON FOOD STAMPS AND WIC. LOGAN RECEIVED A CHECK FROM SSI ON 10/1/09 IN THE AMOUNT OF \$674 FOR THE VICTIM.

LOGAN SAID SHE FIRST NOTICED THE VICTIM LOST WEIGHT AND WAS SKINNY ON WEDNESDAY (10/28/09) OR THURSDAY (10/29/09). LOGAN SAID SHE DIDN'T THINK ANYTHING OF IT BECAUSE THE VICTIM WAS ALWAYS THAT SKINNY. LOGAN SAID THE VICTIM WEIGHED 7 LB. 8 OZ. WHEN SHE LEFT THE HOSPITAL. LOGAN SAID SHE HAD THE VICTIM WEIGHED AT THE HEALTH DEPARTMENT IN AUGUST AND THE VICTIM HAD GAINED 2 OZ. LOGAN SAID THAT ON 11/01/09 AT APPROXIMATELY 0545 HOURS WHEN SHE FOUND THE VICTIM UNRESPONSIVE, SHE NOTICED IT APPEARED HER BONES WERE STICKING OUT OF HER FACE. SHE SAID THE VICTIM'S FACE WASN'T LIKE THAT BEFORE 11/01/09. WHEN ASKED IF SHE THOUGHT ABOUT TAKING THE VICTIM TO THE DOCTOR WHEN SHE NOTICED SHE WAS LOSING WEIGHT, LOGAN REITERATED SHE DIDN'T THINK ANYTHING OF IT.

VONDA STEWARD, ADVISED DETECTIVES SHE CONFRONTED LOGAN TWO WEEKS PRIOR TO 11/01/09 AND TOLD HER THE VICTIM NEEDED TO BE SEEN BY A DOCTOR BECAUSE OF HER WEIGHT. VONDA STEWART ADVISED LOGAN TOLD HER THE VICTIM SAW A DOCTOR RECENTLY AND THAT SHE WEIGHED EIGHT (8) LBS. I CONFRONTED LOGAN WITH THAT INFORMATION AND SHE ADMITTED THE SHE LIED TO HER MOTHER BECAUSE HE MOTHER KEPT HOUNDING HER ABOUT THE VICTIM NEEDING TO SEE A DOCTOR. LOGAN SAID SHE TOLD HER MOTHER THE VICTIM WEIGHED EIGHT (8) LBS. WHEN IN FACT SHE DIDN'T. LOGAN THEN ADMITTED THAT SHE NOTICED THE VICTIM WAS LOSING A LOT OF WEIGHT APPROXIMATELY TWO (2) WEEKS AGO BUT SHE WAS SCARED SHE WAS GOING TO GET IN TROUBLE. THE MEASUREMENTS CORRESPOND TO LESS THAN THE ONE PERCENTILE OF CHILDREN OF THIS AGE. THIS MEANS 99% OF CHILDREN FIVE MONTHS OLD, WEIGH MORE AND ARE LONGER.

NELSON IDENTIFIED THERE WAS A SMALL AMOUNT (LESS THAN 5 CC) OF A THIN WATERY FLUID IN THE VICTIM'S STOMACH. THERE WERE NO FECES IN THE SMALL BOWEL BUT ONLY A PASTE-LIKE SUBSTANCE IN HER COLON. THE VICTIM WEIGHED SIX (6) LBS. AT THE TIME OF THE AUTOPSY. DR. NELSON RELATED THAT THE AVERAGE (50) PERCENTILE OF BABIES AT FIVE (5) MONTHS OF AGE WEIGH 15 % LBS. DR. NELSON ALSO RELATED THE AVERAGE LENGTH OF A FIVE (5) MONTH OLD CHILD IS SIXTY FOUR (64) CM, HEAD TO HEEL. THE VICTIM WAS FIFTY SIX (56) AND A HALF CM, HEAD TO HEEL. THE MEASUREMENTS CORRESPOND TO LESS THAN THE ONE PERCENTILE OF CHILDREN OF THIS AGE. THIS MEANS 99% OF CHILDREN FIVE MONTHS OLD, WEIGH MORE AND ARE LONGER.
