

I, JOHN ALLEN RUBIO, HAVING BEEN WARNED BY  
DET. S. Lucio, WHOSE OCCUPATION IS A POLICE  
OFFICER AT O'CLOCK 7:28PM M, ON THE 11TH DAY OF MARCH  
, 20 03, AT BROWNSVILLE CAMERON COUNTY, TEXAS (AR) THAT I HAVE THE  
RIGHT TO REMAIN SILENT AND NOT MAKE ANY STATEMENT(S) AT ALL AND THAT ANY  
STATEMENT(S) THAT I MAKE MAY BE USED AGAINST ME AT MY TRIAL OR TRIALS. (AR)  
THAT ANY STATEMENT(S) I MAKE MAY BE USED AS EVIDENCE AGAINST ME IN COURT.  
(AR) THAT I HAVE A RIGHT TO HAVE AN ATTORNEY PRESENT TO ADVISE ME PRIOR TO  
AND DURING ANY QUESTIONING. (AR) THAT IF I AM UNABLE TO EMPLOY AN ATTORNEY,  
I HAVE THE RIGHT TO HAVE AN ATTORNEY APPOINTED TO ADVISE ME PRIOR TO AND  
DURING ANY QUESTIONING AND (AR) THAT I HAVE THE RIGHT TO TERMINATE THE  
INTERVIEW AT ANY TIME. I UNDERSTAND ALL OF MY RIGHTS AS STATED ABOVE, AND  
NOW THAT I KNOW ALL MY RIGHTS, IT IS MY CHOICE TO VOLUNTARILY GIVE THEM UP  
AND TO FREELY, INTELLIGENTLY, AND KNOWINGLY MAKE THE FOLLOWING STATEMENT:

MY NAME IS JOHN ALLEN RUBIO D.O.B. 8-12-80  
I RESIDE AT 805 E. TYLER APT. 11. I AM  
CURRENTLY UNEMPLOYED.

TODAY I WAS BROUGHT TO THE BROWNSVILLE POLICE DEPARTMENT. I WAS READ  
MY RIGHTS BY DET. THOMAS CLIPPER. I SIGNED A FORM INDICATING THAT I  
UNDERSTOOD MY RIGHTS. AFTER I WAS READ MY RIGHTS I SPOKE WITH DETECTIVE  
SAM LUCIO. DET. SAM LUCIO HAS ASKED THAT I TELL HIM WHAT I KNOW ABOUT THE  
DEATH OF MY CHILD AND THE DEATH OF MY WIFE'S TWO CHILDREN.

DET. LUCIO HAS ASKED ME WHO MY MOTHER IS AND I HAVE TOLD HIM THAT HER NAME  
IS HILDA B. RUBIO AND SHE IS ABOUT 48 YRS OLD. DET. LUCIO HAS ASKED ME  
ABOUT MY FATHER AND I HAVE TOLD HIM THAT I JUST FOUND OUT MY FATHER'S NAME  
IS MANUEL RUBIO. I HAVE THREE BROTHERS MANUEL RUBIO JR. AGE 24, JOSE LUIS  
LOPEZ AGE 17 AND RODRIGO IVAN BARRIENTES AGE 18.

DET. LUCIO HAS ASKED ME WHAT SCHOOLS I ATTENDED IN BROWNSVILLE. I ATTENDED  
BURNS, CROMACK, CUMMINGS, OLIVEIRA, AND PORTER. I GRADUATED FROM PORTER  
HIGH SCHOOL. DET. LUCIO HAS ASKED ME TO TELL HIM WHERE I HAVE WORKED. I  
HAVE WORKED AT GOLDEN CORRAL, MCDONALDS TWO TIMES AND A COUPLE OF OTHER  
PLACES.

DET. LUCIO HAS ASKED ME IF I AM SEEING ANY DOCTORS AND I AM NOT SEEING  
ANY DOCTORS. DET. LUCIO HAS ASKED ME IF I AM USING ANY DRUGS AND I TOLD  
HIM THAT I HAVE USED MARIJUANA AND ROACH PILLS IN THE PAST. IT HAS BEEN A  
WHILE SINCE I HAVE USED ANY DRUGS ABOUT THREE MONTHS.

MARIA ANGELA CAMACHO IS MY COMMON LAW WIFE. I MET MARIA ANGELA CAMACHO  
2 YRS AGO THROUGH A FRIEND OF MINE. SHE ALREADY HAD ONE CHILD NAMED JULISA  
ANGELA QUESADA AND SHE WAS ALREADY PREGNANT ABOUT ONE MONTH. SHE HAD THE  
BABY AND WE NAMED THE BABY AFTER ME. WE NAMED THE BABY JOHN RUBIO. LESS  
THAN A YEAR LATER SHE BECAME PREGNANT AGAIN AND WE HAD MARY JANE. MARY  
JANE WAS BORN IN JANUARY OF THIS YEAR.

DET. LUCIO HAS ASKED ME WHAT HAPPENED TO JULISA, JOHN AND MARY JANE.  
LAST NIGHT THE CHILDREN STARTED TO ACT LIKE THEY WERE POSSESSED. JULISSA  
(AR)

GRABBED SOME SCISSORS AND SHE WAS GOING TO PLACE THE SCISSORS IN THE ELECTRICAL PLUG. MY DAUGHTER STARTED TO SPEAK LIKE MY GRANDMOTHER WHO HAD PASSED AWAY. JULISSA WAS TELLING ME THAT SHE CAME FROM LIMBO. SHE WAS WAS ACTING LIKE MY GRANDMOTHER SO I ASKED HER IF SHE WANTED ME TO CALL HER JULISSA OR GRANDMA. SHE TOLD ME THAT SHE HAD TAKEN JULISSA'S SOUL.

JULISSA STARTED TO LAUGH IN AN EVIL WAY AND STARTED MAKING GROWLING SOUNDS AT ME. THE OTHER TWO BABIES STARTED TO DO THE SAME THING. THEY STARTED TO TALK AND SAYING THINGS LIKE THREE WITCHES. THEY WERE TALKING TO EACH OTHER. MY WIFE AND I GOT SCARED. MY WIFE TOLD ME TO KILL THE CHILDREN BECAUSE THEY WERE EVIL. I TOLD HER NO THAT I DID NOT WANT TO KILL THEM EVEN THOUGH MY GRANDMOTHER TOOK OVER HER BODY. I HAD TOLD MY WIFE THAT I DIDN'T WANT TO KILL HER BECAUSE I FELT THAT I COULD CONTROL HER.

MY WIFE ANGELA TOLD ME TO GO AHEAD AND KILL THE CHILDREN. MY WIFE THEN WENT AND GOT TWO KNIFES FROM THE KITCHEN. I THEN PICKED UP JULISSA AND SHE WAS STILL TALKING LIKE MY GRANDMOTHER AND GROWLING AT ME. SHE WAS STRONG AND I FELT LIKE SHE COULD MANIPULATE MY MIND. I WAS TRYING TO PUT SPRING WATER ON HER. SHE STARTED TO SHAKE. JULISSA STARTED TO YELL AT ME "YOU ARE KILLING ME, YOU ARE KILLING ME". I THEN PLACED HER ON THE GROUND AND MY WIFE HELD HER DOWN. I THEN STARTED TO CHOKE HER BECAUSE MY WIFE TOLD ME THAT I RATHER HER DIE THEN BE EVIL. MY WIFE THEN GAVE ME THE KNIFE. MY WIFE WAS HOLDING JULISSA WITH HER FACE TO THE GROUND AND I STARTED TO STAB HER IN THE BACK OF THE NECK AND IN THE CHEST. I STABBED HER A COUPLE OF TIMES .

I THOUGHT I HAD KILLED HER BUT THEN SHE GOT UP AND STARTED TO GROWL AGAIN WAS YELLING FOR US TO STOP. SHE YELLED "MOM PLEASE TELL DAD TO STOP". I THEN GRABBED HER AGAIN AND I CUT HER HEAD OFF WITH A MACHETTE. THE BLOOD STARTED TO GUSH AND SHE STOPPED MOVING. JOHN AND MARY WERE STILL ACTING LIKE THEY WERE POSSESSED AND MY WIFE TOLD ME TO KILL THEM ALSO. I THEN KILLED MARY JANE BECAUSE SHE WAS WEAKER. WHEN I TRIED TO GRAB JOHN I FELT THAT HE WAS VERY POWERFUL.

I GRABBED MARY JANE AND I WAS CHOKING HER REALLY HARD BUT SHE WOULD NOT DIE. IT WAS VERY HARD BECAUSE SHE WAS MY OWN BLOOD. I KEPT TRYING TO CHOKE HER BUT SHE WOULD NOT DIE. I THINK I THEN STABBED HER IN THE BACK OF THE HEAD. MARY JANE KEPT MOVING LIKE SHE WAS GOING TO COME BACK TO LIFE. I TRIED TO CUT HER HEAD OFF WITH THE REGULAR KITCHEN KNIFE BUT IT WAS NOT CUTTING THREW. I WAS LOOKING FOR THE MACHETTE BUT I THINK THE WITCHES TOOK THE MACHETTE. I THEN RIPPED HER HEAD OFF WITH MY HANDS IT WAS VERY HARD BUT I MANAGED TO PULL HER HEAD FROM HER BODY. MY WIFE STARTED TO CRY AND WAS TELLING PLEASE NOT MY DAUGHTER. I TOLD HER THAT WE HAD TO KILL THEM BECAUSE AN EVIL PRESENCE WAS IN THEM. WE THEN BOTH STARTED TO CRY.

JULISSA AND MARY JANE WERE KNOW DEAD AND JOHNNY WAS STILL ACTING VERY EVIL. I KNOW THAT HE IS NOT MY SON BUT I STILL LOVED HIM LIKE MY SON. I KNEW I HAD TO KILL JOHNNY LAST BECAUSE HE WAS THE STRONGEST. MY WIFE AND I BOTH HAD TO HOLD HIM DOWN BECAUSE HE WAS SO STRONG. JOHNNY WAS YELLING AND GROWLING AT US. I POURED WATER ON HIM AND HE KEPT SHAKING. I CUT HIS HEAD OFF WITH A LARGER KNIFE. I DID NOT STAB JOHNNY I JUST CUT HIS HEAD. HE WAS BLEEDING ALL OVER THE CARPET. I RATHER KILL HIM THAT LET HIM LIVE WITH THE DEVIL INSIDE HIM. J.A.K.

AFTER THEY WERE ALL DEAD MY WIFE AND I STARTED TO CRY. WE TALKED ABOUT KILLING OUR SELVES BUT WE CANNOT DIE BECAUSE WE ARE IN LIMBO. I TRIED TO CUT MYSELF AND THE KNIFE WOULD NOT CUT ME LIKE IT WAS NOT SHARP IN ENOUGH TO CUT ME.

MY WIFE AND I STARTED TO CLEAN UP THE HOUSE. I PLACED JOHNNY'S BODY IN A BLACK PLASTIC BAG. I PLACED HIS HEAD IN A WHITE PLASTIC BAG. I PLACED JULISSA AND MARY JANE IN ANOTHER BLACK PLASTIC BAG AND I PLACED THEIR HEADS BEHIND THE CRIB IN ANOTHER PLASTIC BAG. I DO NOT KNOW IF THEIR BODIES GOT OUT OF THE BAGS AFTER WE LEFT.

AFTER WE PUT THE BODIES IN A PLASTIC BAGS ANGELA AND I WENT AND TOOK A SHOWER. WE CLEANED OURSELVES OFF FROM ALL THE BLOOD. I DO NOT REMEMBER WHAT WE DID WITH OUR CLOTHES. WE THEN WENT TO THE FRONT ROOM AND I TOLD MY WIFE THAT WE SHOULD MAKE LOVE FOR THE LAST TIME BECAUSE WE WERE GOING TO JAIL. AFTER WE MADE LOVE WE JUST LAID IN BED FOR THE REST OF THE NIGHT TILL THE NEXT DAY.

ANGELA AND I TALKED ABOUT BURRING THE BABIES AT 1404 E. 16TH STREET IN MY GRANDMOTHER'S BACK YARD BECAUSE SHE WAS A WITCH AND SHE COULD CONTROL THEIR EVIL POWER. I THEN STARTED TO THINK AND TOLD MY WIFE MAYBE I SHOULD JUST CALL THE POLICE AND TELL THEM WHAT HAPPENED. EVERYBODY MAKES MISTAKES AND WE ARE NOT ALL PERFECT.

THERE WERE A LOT OF FUMES IN THE HOUSE AND I THINK THIS WAS MAKING US SLEEPY AND NAUSEOUS. MY BROTHER JOSE LUIS LOPEZ GOT TO MY HOUSE AND HE WALKED IN AND HE SAW WHAT HAD HAPPENED. MY BROTHER WAS ALSO POSSESSED AND HE ACTED LIKE HE KNEW WHAT WE HAD DONE. HE STARTED TO TELL ME WHAT DID I DO TO THE CHILDREN. I TOLD HIM THAT "YOU DO NOT KNOW WHAT HAPPENED HERE LAST NIGHT". JOSE LUIS WAS WITH HIS GIRLFRIEND AND SHE DOES NOT LIKE ME. HER NAME IS MAGDALENA AND THEY CALL HER "BEBA" AND SHE KEPT TELLING MY WIFE WHY DIDN'T YOU CALL THE POLICE. MY WIFE WAS JUST IGNORING HER BECAUSE SHE KNOWS WHY I DID THIS.

THE POLICE THEN ARRIVED AND WHEN THE OFFICER SAW ME I JUST TOLD HIM "HEAR JUST ARREST ME I KNOW I DID SOMETHING BAD BUT I RATHER MY CHILDREN BE DEAD THAN BE POSSESSED. I WAS THEN HANDCUFFED AND BROUGHT TO THE POLICE STATION.

I HAVE GIVEN THE ABOVE STATEMENT OF MY OWN FREE WILL. I HAVE NOT BEEN PROMISED ANYTHING OR THREATENED IN ANYWAY IN EXCHANGE FOR THIS STATEMENT. I HAVE READ THE ABOVE STATEMENT AND IT IS TRUE AND CORRECT TO THE BEST OF MY KNOWLEDGE
