

NARRATIVE:

ON THIS DATE, WHILE EN-ROUTE TO DOMESTIC DISTURBANCE CALL. I WAS WAVED DOWN BY A MALE AND FEMALE (WHO WERE LATER IDENTIFIED AS MARIA ELENA ALVAREZ 1-2-86, JOSE LUIS RUBIO 6-16-85) AT THE 1200 BLK OF E MONROE. I ADVISED DISPATCH THAT I WAS BEING WAVED DOWN AT SAID LOCATION. I HAD PULLED OVER AND THE FEMALE TOLD ME IN SPANISH, "THE BABIES ARE DEAD". AT THAT POINT, THE MALE SUBJECT SPOKE UP AND SAID "THEY HAVE NO HEADS". I THEN ASKED THEM WHERE THIS WAS AT, AND THEY TOLD ME IT WAS BY THE BOYS n GIRLS CLUB. BOTH WERE ASKED TO ENTER MY UNIT AND SHOW ME WHERE THIS WAS. WHILE ENROUTE TO THE AREA OF THE BOYS n GIRLS CLUB, THEY REPEATED OUT LOUD THEY HAVE NO HEADS. AS I WAS TURNING THE CORNER FROM 7TH STREET ONTO E TYLER, THEY POINTED OUT A WHITE APARTMENT BUILDING ON THE CORNER OF 8TH AND E TYLER. I THEN ADVISED DISPATCH OF MY LOCATION AND WAS DIRECTED BY THE MALE PASSENGER TO AN APARTMENT DOOR WHICH HAD NO NUMBER. THE MALE PASSENGER THEN KNOCKED ON THE DOOR AND A MALE SUBJECT ANSWERED (WHO WAS LATER IDENTIFIED AS JOHN ALLEN RUBIO 8-12-80) AND I ASKED HIM WHAT'S GOING ON. THE SUBJECT INVITED ME IN THE APARTMENT AND WHILE TAKING TWO STEPS BACK STATED "THE KIDS". I CAUTIOUSLY ENTERED THE APARTMENT AND OBSERVED A FEMALE SUBJECT (WHO WAS LATER IDENTIFIED AS ANGELA CAMACHO 11-11-79) SITTING ON WHAT APPEARED TO BE A SMALL BED OR FUTON. I COULD SEE SHE WAS FACING THE FLOOR AND NOT LOOKING UP. AS I MADE MY WAY FURTHER INTO THE APARTMENT, ONE OF THE PASSENGERS THAT LED ME TO THE APARTMENTS STATED "TELL HIM". THE SUBJECT (OCCUPANT) THEN SAT DOWN NEXT TO THE FEMALE AND STATED "THE KIDS ARE IN THE BACK ROOM". JUDGING BY THEIR WORDS AND ACTIONS, I REQUESTED BACK UP. BASED ON WHAT I HAD BEEN TOLD BY THE CONCERNED PARTIES (ALVAREZ, J RUBIO) AND FEARING THE SAFETY OF THE CHILDREN, I DECIDED TO INVESTIGATE THE MATTER. I ENTERED A SMALL HALLWAY AND IMMEDIATELY GOT A SCENT OF CLEANING FLUIDS (POSS BLEACH). I OBSERVED A ROOM TO MY RIGHT WITH AN OPEN DOORWAY. I APPROACHED THE DOORWAY AND CAUTIOUSLY PEERED INTO THE ROOM. I COULD SEE TO THE RIGHT A BED WITH NO SHEETS AND AN INFANTS CRIB TO THE FAR RIGHT. I ALSO OBSERVED WHAT APPEARED TO BE THE BODY OF AN INFANT CHILD. I ALSO NOTICED THAT THE BODY APPEARED TO HAVE NO HEAD WHATSOEVER. I THEN ADVISED DISPATCH OF A POSSIBLE HOMICIDE-DECAPITATION. I THEN BACKED OUT OF THE HALLWAY WITHOUT TOUCHING OR DISTURBING ANYTHING. I THEN ASKED OUTLOUD "WHAT HAPPENED"? THE MALE SUBJECT (JOHN ALLEN RUBIO) OCCUPANT OF THE APARTMENT APPEARED TO SIGH AND STOOD UP, AND STATED ARREST ME. FOR OFFICER SAFETY, AND TO PREVENT FURTHER CONTAMINATION OF A POSSIBLE CRIME SCENE, I HAD EVERYONE EXIT THE APARTMENT. AS WE EXITED THE APARTMENT, I OBSERVED OFFICER C RENTERIA #5305 AT LOCATION, AND ALSO ARRIVING OFFICER M CARDIEL #5060. I ADVISED OFFICER RENTERIA TO HANDCUFF THE MALE SUBJECT (ALLEN RUBIO) OCCUPANT OF THE APARTMENT FOR

HIS SAFETY AND THAT OF THE OFFICER. OFFICER RENTERIA HANDCUFFED THE MALE SUBJECT AND OFFICER CARDIEL SECURED HIM IN HIS UNIT. AT THIS POINT, DETECTIVES CHRIS ORTIZ #3154, JULIO BRIONES #175, AND SGT. MANRIQUE #3691 ARRIVED AT LOCATION. I ADVISED THEM OF WHAT AWAITED THEM INSIDE THE APARTMENT. I THEN RE-ENTERED THE APARTMENT AND LED DETECTIVE ORTIZ AND BRIONES TO THE BACK ROOM WHERE I HAD DISCOVERED A CHILD'S BODY. I THEN EXITED THE APARTMENT WHERE DETECTIVES SECURED THE WITNESSES (PASSENGERS), THE SCENE, AND TOOK OVER THE INVESTIGATION. UPON FURTHER INVESTIGATION, DETECTIVES AT THE SCENE ADVISED OFFICER CARDIEL TO TRANSPORT SUBJECT (JOHN ALLEN RUBIO) TO CRIMINAL INVESTIGATION DIVISION. I WAS ADVISED LATER OF THREE DEAD INFANTS IN THE HOME. AT THIS POINT, THIS CASE IS A HOMICIDE AND CID TOOK OVER THE INVESTIGATION (SCENE). NO FURTHER ACTION TAKEN BY THIS OFFICER.
