Your affiant informs the court that Ms Sarah Ridgeway works the overnight shift. After seeing Jessica off to school that morning, Ms Ridgeway went to sleep as was her routine. Ms Ridgeway slept through the day and woke up at about 4:11 p.m. when she retrieved the telephone message. Ms Ridgeway called Westminster Police. Your affiant reviewed a report completed by Officer Salazar and learned that when Jessica left for school, she was wearing blue jeans, black boots with pom-poms, and a black "puffy" jacket with pink lining. Jessica also wore purple prescription eye glasses and carried a backpack with her. Your affiant informs the court that Sarah Ridgeway told Officer Salazar that she could not remember the shirt that Jessica wore

Multiple searches of the neighborhood and surrounding areas utilizing several different methods were conducted over the next several weeks but Jessica was not located. As the investigation progressed, investigators believed that Jessica Ridgeway had been abducted.

Your affiant informs the court that on October 7, 2012 at about 12:30 p.m., a backpack was found sitting on the sidewalk at 2255 Andrew Drive in Superior, Colorado. Detective Lopez showed Sarah Ridgeway a photograph of the backpack and contents; all were identified by Sarah Ridgeway as belonging to Jessica. Your affiant later reviewed photographs of the backpack contents and observed that the following were among the items contained inside; blue jeans, blue panties, a white tie-dyed t-shirt, purple prescription glasses, books and notes, a water bottle with the name "Jessica Ridgeway", purple glove and a wooden stick. Sarah Ridgeway told Detective Lopez that the stick did not belong to her daughter. Your affiant informs the court that the black "puffy" jacket with pink lining and green and pink socks were not recovered.

Your affiant informs the court that she later received information from Detective Lopez that the Colorado Bureau of Investigations conducted DNA analysis of the backpack and contents. A DNA profile was developed from swabs from items in the backpack including a swab from the base of Jessica's water bottle. The DNA profile indicated a mixture; the minor component of the mixture was not interpretable; the major component of the DNA profile was entered into the CODIS (Combined DNA Index System) DNA database. CODIS is a database maintained by the Federal Bureau of Investigation into which DNA profiles obtained during investigations can be entered and compared to DNA in the database which can include DNA from known and unknown subjects. The DNA did not match any known offenders, however, the DNA profile developed from Jessica Ridgeway's belongings, matched that of another unsolved and unidentified perpetrator in a Westminster Police Department investigation that occurred on May 28, 2012 at Ketner Reservoir.

Your affiant informs the court that. Ketner Reservoir is located within the same subdivision where Jessica Ridgeway resides. The reservoir is situated less than ¾ of a mile from the site of Jessica's abduction. Your affiant reviewed Westminster Police Department case report number that documented the May 28, 2012 incident; your affiant also spoke with Westminster Police Detective Mike Lynch who completed the investigation and spoke with the victim The report indicates that was jogging around the south side of the reservoir when she passed a man who was walking in the same direction. As she passed the man, he began to run with her. The man put his right arm around her shoulder and neck. The man held a red colored rag in his hand that he put over her mouth. She described the rag being rough in texture like a wash cloth and having a chemical smell, that was possibly gasoline. Struggled with the man and they fell to the ground where the continued to struggle for about fifteen seconds until she was able to break free and run away.

The victim told Westminster Police Detective Lynch that she thought the suspect's intentions were not good and his goal was to "take advantage of her".

In an interview with Detective Lynch, and identified her assailant as a white male who she did not know, he is about 20-25 years old, 5'07" to 5'09" tall, with short brown hair, of average build wearing a blue baseball hat, blue jeans, a dark colored t-shirt and sunglasses. Shirt was seized as evidence and submitted to the Colorado Bureau of Investigations for DNA analysis.

Your affiant reviewed the October 9, 2012 DNA analysis report completed by the Colorado Bureau of Investigations CODIS Casework Administrator, Kristy Kadash. The report indicates that the DNA profile developed from the analysis of the colorado shirt matched the DNA profile developed from Jessica Ridgeway's water bottle.

Your affiant informs the court that on October 10, 2012, human remains, believed to be those of a prepubescent female child were located west of the intersection of W. 82nd Avenue and Quaker Street in Arvada, Jefferson County, Colorado. The remains which consisted of a dismembered female torso was wrapped in black plastic trash bags with red plastic handles. The head, arms and legs were not recovered. An autopsy of the remains was conducted by the Jefferson County Colorado Coroner's Office on October 11, 2012. Further analysis was conducted and it was confirmed that the remains were those of Jessica Christine Ridgeway, the missing 10 year-old child. Your affiant informs the court that a wooden cross measuring approximately 1" x 1 ½" was found to have been inserted into Jessica Ridgeway's vagina. The cause of Jessica Ridgeway's death was not determined.

Your affiant informs the court that additional analysis of the black trash bags that contained the torso was conducted. Your affiant learned from Westminster Police Criminalist Stene that the bags were identified as Kirkland Signature Drawstring Trash Bags; 33 gallon size.

Your affiant informs the court that a multi jurisdictional, multi disciplinary task force was established in effort to identify the person (or persons) responsible for Jessica Ridgeway's kidnapping and murder as well as the individual responsible for the kidnapping and assault of Numerous investigative methods were used including (but not limited to) neighborhood canvas during which the occupants of several hundred homes in Jessica Ridgeway's neighborhood were contacted and interviewed. Additionally a "tip line" was established as a means for the public to call in and notify police of possible leads or suspicious activity related to these crimes. A dedicated e-mail address was also established for the same purpose (Pdamberalert@cityofwestminster.us)

Your affiant informs the court that during the course of this investigation numerous persons were identified for their potential or suspected involvement in these crimes. Court orders for production of records, pen register trap and trace, GPS and orders for non testimonial evidence

were sought and/or obtained. Additionally, the DNA of several hundred people was obtained and submitted to the Colorado Bureau of Investigations for analysis and comparison.

Your affiant informs the court that on October 17, 2012 at about 8:00 p.m., as part of the neighborhood canvas, Mindy Sigg was contacted at the residence at Westminster, CO. FBI Agents Weiss and Holmes met with Ms Sigg who reported that she lived in the home with her children, Austin (Sigg) and Sign No search was conducted of the home.

Your affiant informs the court that on October 19, 2012 a telephone message was left on the tip line for FBI Agent Chris Calarco. The message was from a person in the neighborhood that Agent Calarco spoke with previously. The neighbor spoke anonymously with Agent Calarco and expressed his/her concern about Austin Sigg. The concerned neighbor told the Agent that Austin Sigg worried her/him for several reasons including the fact that Austin Sigg attends mortuary school. Additionally, the neighbor expressed that he/she had a conversation with Mindy Sigg who spoke about concerns of body disposal and DNA issues. The citizen also spoke of Austin Sigg's access to other homes and described Austin's behavior as strange.

Your affiant informs the court that as a result of the tip submitted to Agent Calarco, on October 19, 2012, FBI Agents Deframe and Longoria responded to the Sigg home and met with Austin Sigg. A sample of Austin Sigg's DNA was obtained via buccal swab. Your affiant informs the court that on October 20, 2012 the swab was submitted for analysis and comparison to the Colorado Bureau of Investigations. Your affiant learned from Westminster Police Department Sergeant Rippy that the DNA analysis did not result in a match. The DNA of Austin Sigg did not match the DNA profile obtained from the swab of Jessica Ridgeway's torso, nor did it match the DNA profile developed from Jessica Ridgeway's water bottle or the DNA profile developed from Shirt (from Ketner Reservoir).

Your affiant informs the court that on October 23, 2012 at approximately 7:31 p.m. hours, Westminster Police received a telephone call from Mindy Sigg who resides at Avenue, Westminster, Jefferson County Colorado. Ms Sigg called police to inform them that her son, Austin Reed Sigg (DOB: 01-17-1995) confessed to her that he kidnapped and murdered Jessica Ridgeway. The telephone call completed by Ms Sigg was recorded in the Westminster Police Department Communications Center. During the course of the call, Austin Reed Sigg spoke with the police dispatcher. Your affiant reviewed the recorded telephone call and learned the following information.

Dispatch: This is Molly at the Westminster Police Department

Mindy Sigg: Hi. I need you to come to my house. My son wants to turn himself in for

the Jessica Ridgeway murder

Dispatch: O.k. What's the address?

Mindy Sigg:

Dispatch: What's going on there?

Mindy Sigg: I

He confessed to killing her

Dispatch:

Can you tell me exactly what he said?

Mindy Sigg

He did it. He gave me details and her remains are in my house

Dispatch:

Did you see them?

Mindy Sigg:

Your affiant informs the court that Mindy Sigg identified her son as Austin Sigg and spelled the last name. The dispatcher asked to talk with Austin Sigg and Mindy agreed. Austin got on the telephone and the dispatcher identified herself and the Westminster Police Department. The following is among the information Austin Sigg told the dispatcher:

Dispatch:

Can you tell me what is going on right now or how you're feeling. Or

how did this come about?

Austin Sigg:

I don't exactly get why you're asking these questions. I murdered Jessica

Ridgeway.

Dispatch:

O.k.

No.

Austin Sigg:

I have proof that I did it. There is no question. You just have to send a squad car down here and I will answer all of the questions that you want to

ask, or anyone wants to ask. As soon as, you've got to get down here.

Dispatch:

What part the house are her remains in?

Austin Sigg:

In the crawl space

Your affiant informs the court that Austin then provided his date of birth (January 17, 1995) and information that he is a student at Arapahoe Community College and that he was giving himself up "completely". The dispatcher asked Austin if he committed any other crimes. Austin told her that the only other "thing" that he did was "the Ketner Lake incident" where the woman "got attacked" and he also received a speeding ticket. Also during the conversation with the police dispatcher, Mindy Sigg was asked if Austin had any mental health issues. Mindy reported that her son saw a counselor for pornography a few years ago. Ms Sigg also told the dispatcher that Austin was studying to be a "mortician" at Arapahoe Community College.

Your affiant informs the court that Westminster Police Department Special Enforcement Team (SET) Officers were dispatched to Austin Sigg's residence at a financial Your affiant spoke with Officers A.C. Stutson and Robb Phelps and learned the following information.

When officer's arrived at the home they were met by Mindy Sigg at the front door. Ms Sigg was still on the telephone with police dispatch when they arrived. Austin Sigg was standing just inside the front door. Ms Sigg invited the officers into her home. Austin Sigg was immediately handcuffed by Officer Stutson. Austin complied, he was described as being calm and cooperative and showing no emotion. Officer Stutson escorted Austin to the front porch area; Mindy Sigg was also asked out of the home onto the porch. Officer's requested and received written consent to search the home from Mindy Sigg. An interview with Austin Sigg was conducted by Officer Stutson after Austin verbally waived his rights per Miranda. During the

interview, Austin told the Officer that Jessica Ridgeway's remains could be found in black trash bags, that were just like the bags that her torso was found in.

Officer Phelps went into the basement of the Sigg home and opened the closet that led to the crawl space. Inside the closet were several tall, live marijuana plants in individual pots. Officer Phelps moved the plants aside to access the wooden door that covered the crawl space opening. Upon removal of the covering, Officer Phelps noted that the space extended the entire length of the home estimated to be 300-500 square feet. The room was full of numerous household goods; many in boxes or bins. Officer Phelps located three or four black trash bags that he recognized as similar to those that Jessica Ridgeway's torso was found in. Each bag was secured with a knot. Officer Phelps did not open the bags but felt the exterior; he noted that one bag contained an object that felt to be a human face and hair. In other separate bags, Officer Phelps felt what he thought to be a human arm and leg.

Your affiant informs the court that on October 23, 2012, Austin Sigg was arrested and transported to the Westminster Police Department where he participated in an interview after he and his mother both waived his rights per Miranda. Both Austin Sigg and Mindy Sigg agreed for Austin to participate in the interview with investigators outside of Ms Sigg's presence. Your affiant spoke with Federal Bureau of Investigations Special Agent J. Grusing who viewed the interview as it occurred and told your affiant the following information:

Austin Sigg spoke of his educational background. He was then asked about his role in the kidnapping and death of Jessica Ridgeway. Austin Sigg explained that he drove his Jeep Cherokee to Jessica Ridgeway's block and he sat in the back seat of the Jeep. Once Jessica Ridgeway walked by his vehicle, Austin Sigg grabbed her and pulled her inside. He used zip ties to bind her arms and legs together. Jessica Ridgeway screamed and Sigg promised her that she would be all right to quiet her. He drove around, making random turns for awhile before he drove to the residence he shares with his mother. Austin Sigg drove the Jeep into the garage and closed the garage door behind him. He cut the zip ties off Jessica's hands and carried her up the stairs to his bedroom. He sat her on the bed and showed her a film from Netflix. He then told her to change out of her clothing into a shirt and shorts that he set out for her in his bathroom.

After Jessica changed clothes, Austin Sigg attempted to strangle her with zip ties but he was unsuccessful because the ties dug painfully into the palms of his hands. Mr. Sigg then strangled Jessica Ridgeway with his bare hands until she was no longer breathing. Austin Sigg then moved her into the bathtub and placed her face down in the tub and filled the tub with water to make certain she was not breathing. Next, Austin Sigg used a Sawzall and a razorblade in a utility knife to remove one of Jessica's hands and one of her feet. He removed the hands and cut them into pieces, flushing the parts of the hands down the toilet. Mr. Sigg later removed Jessica's head, legs and arms and placed them in plastic bags. Austin Sigg also placed Jessica's torso in a plastic bag and placed all of the bags under the pool shed in the backyard.

The next night, because of the heavy police presence in the area, Austin Sigg drove his Jeep Cherokee to a neighborhood north in Superior, Colorado with Jessica Ridgeway's backpack. Mr. Sigg described the items in the backpack, to include the clothing Jessica wore during the abduction on October 5, 2012 and a wooden stick that was missing bark. Austin Sigg threw the coat Jessica had been wearing into a random trashcan. He also threw away the blade from the Sawzall he used to dismember her. Austin Sigg explained that the purpose of placing the backpack in the northern neighborhood was to divert police from searching his residence.

Austin Sigg stated that because police were using cadaver dogs and thermal imaging, he later decided to get rid of Jessica Ridgeway's torso. Austin Sigg brought the torso back into the house (from the pool shed), washed it a second time and placed it into two black plastic bags with red ties, tying the handles of both bags together. Mr. Sigg emptied the organs out of Jessica Ridgeway's body and flushed them down the toilet in his bathroom. Austin Sigg was careful to use gloves and not leave his fingerprints on Jessica Ridgeway's body. He then drove his Jeep Cherokee to an area and discarded the bags containing the torso. Austin Sigg stated that he placed a cross in Jessica Ridgeway's pelvic area in effort to cause investigators to consider a religious zealot as being responsible for the murder. Austin Sigg took the cross from a small rope used as a necklace for the cross in his bedroom. He explained that he has possessed the cross for a long time and did not recall where or how he first received it. Later during the interview, Austin Sigg clarified that he actually placed the cross in the vagina of Ridgeway.

Mr. Sigg stated that he placed the Sawzall in a large drawer in the bottom right hand cabinet of the garage. He moved the other bags containing the head, arms and legs of Ridgeway to a crawl space under the house.

Austin Sigg stated that he was also responsible for attacking a female jogger on Ketner Lake. He said that he researched how to make chloroform on the internet prior to the incident. He used bleach and acetone to make the chloroform and he poured it on a rag. Mr. Sigg described how the jogger passed him the first time and then how he grabbed her from behind the second time she came around the lake. The jogger pushed him off and ran away. When Austin Sigg was asked by investigators what he planned to do to the jogger, he replied words to the effect of, "Do to her what I did to Jessica."

Your affiant informs the court that according to Westminster Police Department Detective Pyler who also watched a portion of the interview that, Austin Sigg also reported that he enjoyed viewing violent pornography. Austin would explain that he watched frequently watched pornography he described as "dark" and utilized any visual media to do so; his computer, the home computer, cellular telephones and other devices.

Your affiant spoke with Jefferson County District Attorney Investigator Russ Boatright who participated in the interview with Austin Sigg. Investigator Boatright told your affiant that Mr. Sigg recalled tht he wore one of two pair of shoes during the kidnapping, murder and dismemberment of Jessica Ridgeway. The shoes were either the pair that Austin was wearing

during the interview or a pair of "boat shoes". Additionally, Investigator Boatright told your affiant that Austin Sigg used black and green scissors during the dismemberment of Jessica. Additionally, Austin Sigg said that when Jessica was first introduced to his bedroom he had her sit on the bed in various locations. Mr. Sigg also admitted that he strangled Jessica Ridgeway while she was on the bed.

Your affiant informs the court that she requested registered vehicle information from the Colorado Department of Motor Vehicles for the Jeep Cherokee that Austin Sigg reported belonged to him. Your affiant learned that Austin Reed Sigg is the registered owner of a 2002 Gold Jeep Grand Cherokee bearing Colorado license plate: and VIN:

Your affiant spoke with Westminster Police Department Detective Troy Gordanier who observed the residence located at Westminster, Colorado. Detective Gordanier informed your affiant that the Gold Jeep Cherokee is currently parked in the driveway of the Sigg home.

Based on the aforementioned facts your affiant believes that Austin Sigg committed the crime of Murder in the First Degree and Second Degree Kidnapping as outlined in C.R.S. 18-3-102 and C.R.S. 18-3-302 and the fruits and/or instruments of those crimes are located at Westminster, Jefferson County, Colorado.

Based on the aforementioned facts and circumstances, application is hereby made for issuance of a search warrant, directed to any officer authorized by law to execute warrants in the county wherein said property is located, along with Agents or designee of the Federal Bureau of Investigations Evidence Response Team; commanding said officers to search forthwith the person or place named above for said property, and the said property and every part thereof to take, remove and seize, using such force as may reasonably be required in the execution of the warrant, and directing the return thereof be made to the Judge issuing the warrant.

Based on the information provided in this application, your affiant believes that the disclosure of the requested search warrant could jeopardize the on-going investigation, could result in the fight from potential prosecution of (possible) accomplices or possibly subject any potential witness to some form of retaliation or intimidation. Therefore, your affiant further requests that the court SEAL this affidavit as well as the accompanying Search Warrant and direct that no person shall disclose the existence of this search warrant and affidavit to any other person until further order of the court.

The affiant has read the above and foregoing application and affidavit, and the statements therein contained are true to the best of his knowledge, information and belief.
